Minutes of the Special Governing Board Meeting Wednesday, October 11, 2006 Board Room – Wicklund Elementary School

Others present included: Mr. and Mrs. Jack Sung, Parents; 7th Grade Student; Lem Vergara, Principal; Debbie Wingo, Assistant Principal; and Bill Lebo, District Superintendent.

It was moved by Atul Khanna and seconded by Matt Balzarini to approve the agenda as presented. Motion carried with four (4) ayes and one (1) absent.

It was moved by Chris Cunningham and seconded by Matt Balzarini to adjourn the meeting to closed session for the purpose of conducting student expulsion hearing 06-07-01. Motion carried with four (4) ayes and one (1) absent.

At this time, the Governing Board conducted the expulsion hearing involving the Parents, Student, and Administration.

It was moved by Chris Cunningham and seconded by Atul Khanna to return the meeting to an Open Session for the purpose of taking action on the expulsion hearing.

It was moved by Matt Balzarini and seconded by Chris Cunningham to approve the Governing Board's decision regarding expulsion hearing 06-07-011 which is to:

1. Expel the student pursuant to Ed Code Section 48918 for this trimester and the 2nd trimester.
2. Suspend the expulsion pending student's ability to follow school discipline policy rules.
3. The student is to immediately report any incident of bullying to Wicklund School Staff and Administration.
4. The student is not allowed to participate in extra-curricular school activities for the current trimester.
5. The student and parents were reminded of the possibility of law enforcement involvement should another similar incident take place.
6. The parents and students will attend a post-expulsion hearing at the end of the second trimester.

It was moved by Chris Cunningham and seconded by Atul Khanna to adjourn the Special Meeting of the Governing Board at 6:43 P.M. Motion carried with four (4) ayes and one (1) absent.
